

ROCKY ROCOCO “Graduation Party/Scholarship Giveaway” Official Rules 2023

NO PURCHASE IS NECESSARY TO WIN. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

Participation in the Sweepstakes constitutes full and unconditional agreement to and acceptance of these Official Rules and the decisions of Sponsor, which are final and binding. Includes party for the winner for up to \$250 value, including free delivery within an 8-mile radius of Rocky Rococo location. Credit is valid for one lunch or dinner order. Prize is valid Monday – Sunday from 11 A.M – 7 P.M. Unused credit is not eligible for cash payment. Eligible food items include pizzas, slices, breadsticks, salads, pastas, cookies and drinks. Any charges beyond the \$250 value will be the
